Item No.94.1: Confirmation of the Minutes of 92nd & 93rd Executive Council Meeting:

The Executive Council confirmed the Minutes of the 92nd EC and 93rd Special EC meeting held on 25th July 2016 and 11th November 2016 respectively.



Item No.94.2: Action Taken Report (Follow-up Action):

The Executive Council noted the Action Taken against the previous Executive Council held on 25th July 2016 and 11th November 2016 with following observations:

Item No.92.2.i: Executive Council instructed to make all the ACs functional by installing new transformer through CESU by March 2017.

Item No 92.2.ii: In order to expedite the procurement of equipment/services with due transparency and economy, Executive Council instructed that 2nd time e-tender may be published in case of non-availability of adequate numbers of bidders in the first e-tender. In case of non-participation of adequate numbers bidders against e-tender published for the 2nd time, the tender may be accepted with the available bidders even if there exists a single eligible bidder. In such a case, before awarding the order to the bidder wherein less than three bidders applied in the 2nd e-tender, this may be ensured that wide publicity is made and the price of the lowest quotee is reasonable in comparison to market rate.

Item No. 92.5 Executive Council instructed to Establish 24X7 Helpline Desk by March 2017.

Item No.92.9 Executive Council instructed to discuss the SIU Report with Employees Union and Officers' Association and submit the report by 10th January 2017.

Item No.92.10 Executive Council instructed to complete the recruitment process latest by March 2017. EC also instructed to impose Hydrotherapy Fees @ Rs.25 per sitting for BPL Category and RS.50 per sitting for APL category.

- Item No. 92.11 Executive Council instructed to establish the Nuapada Centre by March 2017.
- Item No. 92.12 Executive Council instructed to write another letter to the CMD, RECL through the Chairman EC and asked Director to meet personally to the authorities of RECL for early disposal of the file for CSR Assistance of Rs.15.89 crore to construct 100 Bedded Annexe Building.
- Item No.92.23 Executive Council approved engagement of Legal Consultant @ Rs.20,000/- per month. The incumbent will be selected by Assistant Solicitor General, High Court of Odisha, Govt. of India.
- Item No.92.24 Executive Council noted the progress of implementation of revised RR to create promotional avenues for the staff. Executive Council also agreed to change the Recruitment Rule of Asst. Professor (Ortho/PMR) to correct the typing error occurred in Sl. No.13 for DPC Composition, EC also agreed to change the RR of Plaster Technician because of its difficulty in adopting promotion from the post of Nursing Assistant. The RR of Assistant Professor (Ortho/PMR) and "Plaster Technician" are placed below for approval:
