CET-2020 Third counselling will be held on 12.01.2021 to fill up seats remained vacant after 1st & 2nd counselling and cancellation of admission thereafter, details given below. Additional vacant seats will also be filled up if any vacancy arises on cancellation of admission after this notification on or before 12.01.2021.

VENUE: Examination Hall, 2nd floor, Academic Building, SVNIRTAR, Olatpur, Cuttack, Odisha-754010.

Reporting Time: 10 AM.

Eligibility:

1. Following category candidates are permitted to attend CET-2020, 3rd counselling cum admission.
 - i. Candidates those who have reported during 1st/ 2nd Counselling having common rank from 001 to 1056.
 - ii. All SC & ST candidates attended 1st Counselling.
 - iii. All EWS candidates reported during 1st/2nd Counselling.
2. Candidates who were already admitted at SVNIRTAR, Cuttack/ NILD, Kolkata/ NIEPMD, Chennai through CET-2020 1st/2nd Counselling are eligible. Candidate may change their Institute and Course, subject to availability of vacancy during the time of Counselling. No further request for change of Institute/ Course will be entertained.
3. Any other candidates who have not got choice of seat but Reported during 1st/2nd Counselling are also eligible as per their Rank.
4. Seats under ST category will be converted & interchangeable to SC category.
5. The selection & call for counselling of the candidate is provisional & does not guarantee for admission. If any false information or discrepancy is observed at any stage of admission or the period of study, his/her candidature shall stand cancelled.
6. The candidates will be offered the seat and Institute available/vacant at his/her turn. Each candidate will have to select course and Institute (Subject to eligibility) from the available seats at his/her rank in the Institutes.
7. A candidate, who fails to appear in person on the notified date and time for counselling shall forfeit his/her claim for admission.
