Quotations are invited from reputed firms dealing with repairing and maintenance of cooling equipments/ package-type AC units, who have executed similar works for other Government departments/ Public sectors/ reputed organizations, for execution of the above work so as to complete the same as per following terms and conditions.

Bidders must submit their sealed quotation by **12 noon on 07.05.2022** at the Office of the Construction & Maintenance Division of SVNIRTAR, Olatpur. The bidder is requested to visit the site and check the non-functional AC unit properly before submitting his quotation.

GENERAL INSTRUCTIONS AND TERMS AND CONDITIONS

1. Work has to be completed within 7 days of receipt of work order.
2. The service provider shall provide warranty of 6 months for all other spares/ works from the date of completion of work.
3. Price to be specified clearly both in figures as well as in words. Any ambiguity in quoting the rates shall disqualify the bidder.
4. The rates are to be quoted in Indian currency only.
5. Bidder must specify the taxes, as applicable.
6. Bidder must have valid GSTIN.
7. No residential accommodation can be provided to the successful bidder/ service provider or the technicians during execution of work.
8. The service provider shall use own tools for executing the work.
9. All spares, as required, shall be new and of acceptable quality and manufacture. All damaged spares removed from the cooling equipments shall be handed over to the Engineer-in-charge.
10. The selected vendor is responsible for due compliance of laws/ norms relating to safety during maintenance of cooling equipments.
11. Payment will be released only after satisfactory execution of work as per terms of contract, approximately within 30 days after deduction of taxes at source.
12. The entire risk and responsibility pertaining to this contract regarding the safety & security of men, materials & machine shall rest on the vendor.
13. DISPUTES & ARBITRATION:
 - a) All the disputes relating to the meaning and instructions under this contract hereinbefore mentioned shall be referred to the High Court of Odisha, Cuttack and any decision in this regard would be final for both the parties.
